Reference captioned subject, it is informed that in accordance with Terms & Conditions of respective DG ESIC Rate Contracts, actions have been taken against following firms as per recommendations of the committee for supplying 'Not of Standard Quality' drugs to ESIC and ESIS Institutions for the period Jan-2022 to June -2024.

In context to above, it is again reiterated that:

- 1. No order should be placed to the approved pharmaceutical firms for above listed drugs, which have been found to be "Not of Standard Quality" on test analysis in respective Rate Contracts.
- All ESI Institutions are requested to strictly monitor the quality of supplied drugs in adherence to the quality control clause of DG ESIC Tender Enquiries.
- 3. All ESI Institutions are requested to increase the frequency & number of sampling of Antihypertensive, Anti-diabetic & Antibiotic drugs for quality assurance supplied by approved pharmaceutical firms.
- 4. ESI Institution are requested to keep strict vigil on the performance of above said firms in respect of supply of other items under DG ESIC RCs with regards to quality and if any NSQ is reported, the same may be immediately brought to notice of ESIC, HQRS Office for initiating further necessary actions.
