With reference to above cited subject, in continuation to our earlier letter as above referred letter no 2,3 & 4, all the respective hospital/ offices had been informed that installation of Roof Top Solar Power Project (RTSPP) on the left-out roof top of all ESIC buildings across the country is to be installed. In this connection, it is to inform that REIL has finalized the state-wise developers to install the Roof Top Solar PV panel in the left-out buildings of EST Corporation across the country. The Notice of Award (NOA) under RESCO model have been released to the respective bidders after Technical Evaluation & Reverse Bidding process and same was communicated to ESIC HQ by REIL, through email dated 30.11.2023 & 6.02.2024. The list of selected developers along with levelized tariff across the country is enclosed herewith for ready reference.

Hence, the selected developers will approach you for survey/ assessment of potential of generating power, implementation of Solar Power Plant the Power Purchase Agreement (PPA has to be signed between respective office in-charge/Estate Officer and developer as per MNRE, format, which is already duly approved by Competent Authority and communicated vide this office letter dated 31.01.2019 (copy enclosed). It is worth mentioning here that installation of the solar power plant at sites will be started by the REIL/Developers only after the signing of this PPA

In view of above, it is requested that respective Office in- charge/Estate officers may sign the PPA on top most priority, so that installation of Roof Top Solar power Project (RTSPP) could be completed as early as possible for implementation of the Roof Top solar power plants.
