MEMORANDUM

Subject:-	REVISED DRAFT/PROVISIONAL GRADATION/SENIORITY LIST IN THE CADRE OF ASSISTANT/HEAD CLERK (Pay Level-6) FOR THE YEARS 2014-15, 2015-2016, 2016-2017, 2017-18 and 2018-reg.

The following Final All India Gradation/Seniority Lists of Assistants/ Head Clerks promoted through DPC/LDCE for the Years 2014-15, 2015-16, 2016-17, 2017-18, 2018(April-December) were circulated vide this office Memorandum as under:-

The Hon'ble CAT, Chandigarh vide its order dated 16/2/2024 in OA No. 375/2021 filed by Shri Amit Bahadur & others has ordered for revision of the seniority list of Assistant/HC after considering the representation of the applicants. Accordingly, the matter was examined in detail after taking legal opinion from the legal counsel and the Competent Authority has accorded his approval for accepting the order dated 16/2/2024 of Hon'ble CAT, Chandigarh in OA No. 375/2021 and for its implementation. The Competent Authority has also directed for revision of All India seniority lists of Assistant/HC for other relevant years in order to give effect to the same principle as laid down in DoPT instructions for preparing seniority lists in keeping with the order of the Hon'ble CAT, Chandigarh, after considering the pending representations received against seniority list of Punjab region.

After considering the above, the Competent Authority has decided to issue the draft All India seniority lists of Assistant/HC for the years 2014-15, 2015-16, 2016-17, 2017-18, 2018(1/4/2018 to 31/12/2018) for circulation and for seeking objections/representations , if any, from the officials concerned through Regional Director.

The draft seniority lists may kindly be circulated among all concerned employees and they may be directed to submit their representations/objections (if any) latest by **30th August, 2024.** Regional Offices should invariably forward such representations/objections received by them to this office (Estt. Branch-II, Hqrs. Office) by email on or before **6th September, 2024** alongwith the detailed comment of the Regional Director in r/o each objection/representation , so as to enable Hqrs. Office to finalize the seniority lists in accordance with the instructions on the subject. The representations/objections received after the above date will not be considered and the All India seniority lists shall be finalized accordingly.

The above said seniority lists are subject to outcome of court cases, if any, pending for decision before the Hon'ble Courts.

This issues with approval of the Competent Authority.
