Please find attached Judgment of Hon'ble CAT, Delhi as well as Hon'ble High Court of Delhi W.P.(C) 12260/2024 filed by Dr. Ankit Sharma & Ors, in W.P.(C) 12261/2024 filed by Dr. Barun Kumar Singh & Ors, and in W.P.(C) 12264/2024 filed by Dr. Ankit Kumar Shahi & Ors.

In this connection, all Dean/Medical Superintendents of ESIC PGIMSR/PGIMSR-MC/Medical Colleges/Dental Colleges/ESIC Hospitals are directed to relieve all concerned JRs at the end of completion of one year of Bond Service as both Hon'ble courts have not granted any liberty.

Further some of our MSs/Deans are defending similar cases filed by Bond MBBS & Bond BDS JRs who have desired that they may be allowed to serve the original period of 3/ 5 years of Bond Service instead of the presently mandated one year. They are directed to communicate this judgment to the conducting Advocates who must bring it to the notice of the respective courts urgently and endeavor to obtain similar orders in favor of ESIC, expeditiously.
