1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid

opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

7. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

Decision of the Competent Authority shall be final and binding. Any deviation from the technical specifications mentioned in the bid shall not be accepted.

4. The bidder shall supply the same make, brand and quality of items as the approved samples submitted during the technical evaluation.

5. The price quoted per unit as per BOQ shall be considered for finalizing the Rate Contract. Prices shall be quoted per unit / per pack basis as specified in the bid document and shall include all necessary components required for effective use of the item.

6. Prices quoted must be firm and inclusive of all taxes, duties, freight, insurance, packing, forwarding, handling and delivery charges up to ESIC Hospital, Tiruppur.

7. Rate Contract Validity

The Rate Contract shall remain valid for one (01) year from the date of signing of agreement by the Medical Superintendent, ESIC Hospital, Tiruppur.

The contract may be extended for another one (01) year on mutual consent with the same terms, conditions and rates.

8. ESIC Hospital, Tiruppur shall place supply orders as per requirement, item-wise or quantity-wise during the validity of the Rate Contract.

9. The quantity mentioned in the tender is indicative only and may increase or decrease depending upon an actual requirement. No minimum quantity is guaranteed.

10. The bidder shall supply the ordered items within 30 days from the date of issue of supply order.

11. All laboratory consumables, reagents, chemicals and diagnostic kits supplied shall have a minimum remaining shelf life of 75% of the total shelf life or at least 12 months from the date of supply, whichever is earlier.

12. All items shall be properly packed, sealed and labeled as per statutory norms clearly indicating:

- Batch Number
- Manufacturing Date
- Expiry Date
- Manufacturer Details
- Sterility Status (wherever applicable)

14. Bidder/OEM shall possess valid regulatory approvals such as ISO / CE / CDSCO / BIS / US-FDA certification

ons wherever applicable.

Regulatory compliance shall be as per guidelines of **Central Drugs Standard Control Organization under the provisions of the **Drugs and Cosmetics Act 1940.

15. Delivery of the items shall be made at ESIC Hospital, Tiruppur at bidder's own risk and cost.

16. The bidder shall ensure uniform quality and consistency of the supplied items throughout the contract period.

17. If any supplied item is found defective, damaged, expired, substandard or not as per specification, the same shall be replaced free of cost within 7 days.

18. Any rejected item shall be replaced immediately at the bidder's own cost without financial implication to ESIC.

19. Wherever applicable, the bidder shall ensure proper cold chain maintenance during transportation and delivery. Failure to maintain cold chain may lead to rejection of the material.

20. The bidder shall provide the complete address, official email ID and contact number of the authorized person for communication and placement of supply orders.

21. All supply orders shall be sent through the designated email ID / phone number. Any change must be informed immediately in writing.

22. ESIC Hospital may place supply orders up to the last date of Rate Contract validity, and supplies against such orders may extend beyond the contract period.

23. The bidder shall not sublet, assign or transfer the Rate Contract without prior written permission from ESIC.

24. Failure to comply with tender terms shall be treated as breach of contract, and ESIC reserves the right to make alternative arrangements at the risk and cost of the bidder.

25. Performance Security

The successful bidder shall submit Performance Security @ 5% of (Quoted Price × Estimated Annual Quantity) in the form of Demand Draft in favour of ESIC Fund A/c No.1 payable at Tiruppur.

26. Performance Security shall be refunded without interest after successful completion of the Rate Contract period plus two (02) months, subject to satisfactory performance of the contract by the bidder. In case the Rate Contract is extended, the validity of the Performance Security is also extended accordingly for the entire extended period of the contract.

27. In case of unsatisfactory performance or violation of tender conditions, the Rate Contract may be cancelled and the Performance Security shall be forfeited. The bidder may also be blacklisted from future tenders of Employees' State Insurance Corporation.

28. Payment Terms

Payment shall be made through RTGS / NEFT within 42 days from the date of receipt of goods and submission of correct invoice, subject to verification and certification by the Stores/User Department.

29. Penalty for Delay

If the bidder fails to supply the items within the stipulated delivery period, a penalty of 2% of the order value per week or part thereof shall be levied, subject to a maximum of 10% of the supply order value. The penalty shall be deducted from the payable bills or adjusted against the Performance Security.

30. The Medical Superintendent, ESIC Hospital, Tiruppur reserves the right to accept or reject any or all tenders without assigning any reason.

31. Force Majeure Clause

1. Contractor shall not be liable for, forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that its delay in performance or other failure to perform its obligations under the contract is the result of an event of Force Majeure.

2. For purpose of this clause, "Force Majeure" means an event beyond the control of contractor and not in

volving contractor's fault or negligence and not foreseeable. Such events may include, but are not restricted to war, or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

3. If a Force Majeure situation arises, contractor shall promptly notify the Medical Superintendent, ESIC Hospital, Tiruppur in writing of such conditions and the cause thereof. Unless otherwise directed by the Medical Superintendent in writing, contractor shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

32. Arbitration

Any dispute and differences relating to the meaning of the specifications, design, drawings and instructions herein before mentioned and as to the quality of workmanship of materials used in the work or as to any other question, claim, right, matter of thing whatsoever in any way arising out of or relating to the contract, designs, drawings, specifications, estimates, instructions or these conditions or otherwise concerning the works or the execution or failure to execute the same whether arising during the progress of the work or after the completion or abandonment thereof in respect of which amicable settlement has not been reached, shall be referred to the Sole Arbitration of the Arbitrator appointed by Medical Superintendent, ESIC Hospital, Tiruppur who shall proceed as per the Arbitration Act, 1996 (as amended as rules framed there under) jurisdiction of Tiruppur.

The work under the contract shall continue, during the Arbitration proceedings.

The award of the Arbitrator shall be final, conclusive and binding on both the parties
